NORWICH CITY FOOTBALL CLUB x GREENE KING PRIZE COMPETITION TERMS & CONDITIONS

1. Norwich City Football Club

"NCFC" means Norwich City Football Club PLC, a public limited company registered and incorporated in England and Wales with company number 00154044 whose registered address is Carrow Road, Norwich, Norfolk, NR1 1JE.

2. The competition

- 2.1 The title of the competition is GREENE KING MAGIC MOMENTS.

3. How to enter

To comply with this obligation NCFC will send the surname of the winner to anyone who writes to NCFC at Carrow Road, Norwich, NR1 1JE (enclosing a self-addressed envelope) within one month of the Closing Date.

7. Claiming the prize

- 7.1 NCFC will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not responded to NCFC by 12.00pm on Wednesday 17th April 2024, NCFC reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the Closing Date.
- 7.2 NCFC does not accept any responsibility if you are not able to take up the prize.

8. Limitation of liability

Insofar as is permitted by law, NCFC, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of NCFC, its agents or distributors or that of their employees.
